1. Expenditure under S137 Local Government Act 1972

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.

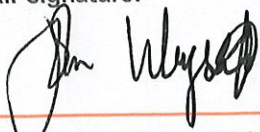
In 2024-25, the Council made payments totalling **£534.14** under section 137. These payments are included within 'Other payments' in the Accounting Statement.
2. Note in respect of Annual Governance Statement Item 1: The Council has not yet totally engaged with the community, to develop a vision and purpose to inform the Council's plans, budget and activities. However, the Council has made tentative enquiries regarding a Community Place Plan with the Unitary Authority, with members currently undertaking 'Community Place Plan' training prior to calling on members of the community to partake in a working group to develop a Community Place Plan.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Penhow Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 7: the Council's internal controls require Council approval of payments prior to payments being made. My audit identified that this control is not applied consistently.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Members' Interests

Section 81 of the Local Government Act 2000 requires the Council to publish a register of members' interests. We noted that the published interests have not been updated since 2022.

We recommend that the Council reviews its register of interests to ensure it is up to date.

Budget requirement

The Council has not provided evidence that it calculated its budget requirement in accordance with the Local Government Finance Act 1992. The Act requires the Council to take into account its income and level of reserves when setting its budget requirement. The Council's budget does not make clear whether or not it has considered its reserves.

We recommend that the Council sets a budget in accordance with the Act.

There are no further matters I wish to draw to the Council's attention.

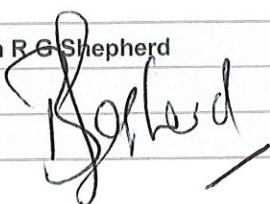
